The Purchasing and Contracting Office formally solicited and received bids for the Nikiski Fire Service Area Station #1 High Flow Pump Upgrade. Bid packets were released on February 18, 2015 and the Invitation to Bid was advertised in the Peninsula Clarion on February 18, 2015.

The project consists of: Complete supply and installation of a 500gpm pump system and controls with all necessary electrical and plumbing connections. Demolition of old system equipment is included. Supply and installation of additional lighting and outlets as outlined in the construction documents.

On the due date of March 18, 2015, five (5) bids were received and reviewed to ensure that all the specifications and delivery schedules were met. The low bid of \$67,620.00 was submitted by Legacy Electric, Soldotna, Alaska.


