Seat H – Doris I. Cabana for a 3-year term


Seat I – Ralph E. Broshes for a 3-year term

**SECTION 14.** That Proposition No. 1, Manager Plan of Government was defeated by the voters of the borough.


**SECTION 15.** That Proposition No. 2, Sales Tax Cap Increase was defeated by the voters of the borough.

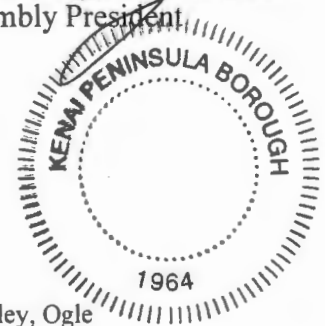
**SECTION 16.** That this resolution takes effect immediately upon its adoption.
