The Purchasing and Contracting Office formally solicited and received bids for the Tall Tree Bridge Rebuild & Road Upgrade. Bid packets were released on July 8, 2015 and the Invitation to Bid was advertised in the Peninsula Clarion July 8, 12 & 15, 2015 and Homer News July 9 & 15, 2015.

The project consists of subgrade modification, clearing, ditching, roadbed widening and bridge repair.

On the due date of July 22, 2015 four (4) bids were received and reviewed to ensure that all the specifications and delivery schedules were met. The low bid of \$251,814.50 was submitted by East Road Services, Homer, Alaska. The total costs for this project are \$295,852.00.


