

KENAI PENINSULA BOROUGH REPORT OF CANVASS BOARD
October 24, 2017 Mayoral Runoff Election

The Borough Canvass Board has canvassed the October 24, 2017 Mayoral Runoff Election ballots cast by the five By-Mail precincts; the absentee ballots cast by mail, fax and in person; special needs ballots and the questioned ballots cast at the polls on election day. Our findings are as follows:



We, the undersigned, certify the foregoing to be true and accurate to the best of our knowledge and belief.




