**KENAI PENINSULA BOROUGH
ORDINANCE 2014-19-51**

AN ORDINANCE REDIRECTING \$127,781 DEOBLIGATED FUNDS FROM THE U.S. FISH & WILDLIFE SERVICE, COASTAL IMPACT ASSISTANCE PROGRAM TO THE ADOPT-A-STREAM EDUCATION PROGRAM

WHEREAS, the Coastal Impact Assistance Program (CIAP) was established under Section 384 of the Energy Act of 2005 and authorizes the Secretary of the Interior to disburse funds to Outer Continental Shelf oil and gas producing states; and

WHEREAS, the borough received fifteen CIAP project awards as adopted by KP Resolution 2009-018, approved in the Alaska Department of Natural Resources State Plan and awarded through CIAP; and

WHEREAS, deobligated CIAP funds in the amount \$127,781 are available to be redirected to the Adopt-A-Stream Program; and

WHEREAS, the borough applied for and received an amendment from U.S. Fish & Wildlife Service to increase the Adopt-A-Stream Program from \$233,272 to \$361,053; and

WHEREAS, the approved amendment in the amount of \$127,781 shall be subawarded to Kenai Watershed Forum, which is the approved subrecipient that may conduct the Adopt-A-Stream Education Program within the Kenai Peninsula Borough School District;

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

SECTION 1. That the mayor is authorized to redirect the U.S. Fish & Wildlife Service, Coastal Impact Assistance Program deobligated funds totaling \$127,781 to the Adopt-A-Stream Education Project account number 271.21135.20121.49999 as follows:

- Funds in the amount of \$3,793.20 are redirected from the Kenai River Near Bank Turbidity Study Project account number 271.21135.11041.49999; and
- Funds in the amount of \$19,881.12 are redirected from the Kachemak Drive Bluff Erosion Study Project account number 271.21135.11063.49999; and

- Funds in the amount of \$56,911.90 are redirected from the Flood Plain Development Survey Benchmarks Project account number 271.21135.11097.49999; and
- Funds in the amount of \$7,499.25 are redirected from the Seward Weather Ocean Observing System Project account number 271.21135.11104.49999; and
- Funds in the amount of \$36,743.06 are redirected from the Planning & Administration Project account number 271.21135.15160.49999; and
- Funds in the amount of \$2,952.47 are redirected from the Crooked Creek State Recreation Area Bank Restoration Project account number 271.21135.15161.49999.

SECTION 2. That grant funds totaling \$127,781 are subawarded to Kenai Watershed Forum, for the Adopt-A-Stream Education Program within the Kenai Peninsula Borough School District.

SECTION 3. That the mayor is authorized to execute a grant agreement and any other documents deemed necessary to accept and expend the grant, and to fulfill the intents and purposes of this ordinance.

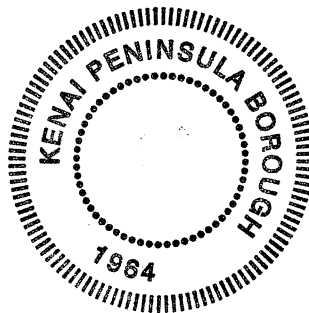
SECTION 4. This ordinance shall become effective immediately upon its enactment.
