RE: FY2024 FINAL Employer On-Behalf Funding Statement - PERS ER 180

During the 2023 legislative session, House Bill HB39 (SCS CSHB39) passed providing on-behalf funding for PERS employer contributions for Fiscal Year 2024 (FY2024). HB39, Section 74. The bill can be found at: https://www.akleg.gov/PDF/33/Bills/HB0039Z.PDF (Section 74, page 166). The final funding language reads as follows:

(a) The sum of \$37,942,000 is appropriated from the general fund to the Department of Administration for deposit in the defined benefit plan account in the public employees' retirement system as an additional state contribution under AS 39.35.280 for the fiscal year ending June 30, 2024.

The Alaska Retirement Management Board approved the actuarially determined rate of 25.10% for FY2024, with HB39 providing an on-behalf rate of 3.10% for each FY2024 employer payroll. On-behalf funding is applied with the processing of each employer payroll with payroll end dates between July 1, 2023 and June 30, 2024 and fully received by the Division by July 15, 2024. A fully received and processable payroll must include payment, an employer summary, and any other required documentation (WIRE and ACH payments must have a corresponding Memo). All such payrolls have been processed, thus we have trued-up your account and made an adjusting entry.

Included is a report detailing the Employer On-Behalf Funding allocated for fiscal year 2024 payrolls. **This is your final adjusted statement for FY2024.** Please work with your accountant or auditor to determine where to show this funding on your financial statements.
