**KENAI PENINSULA BOROUGH  
ORDINANCE 2015-19-14**

**AN ORDINANCE ACCEPTING AND APPROPRIATING \$51,114 FROM THE STATE OF ALASKA DEPARTMENT OF MILITARY AND VETERANS AFFAIRS, DIVISION OF HOMELAND SECURITY AND EMERGENCY MANAGEMENT FOR PORTABLE RADIOS AND TRAVEL REIMBURSEMENT**

**WHEREAS,** the Division of Homeland Security and Emergency Management provides funds through the State Homeland Security Program for the purpose of purchasing equipment that may be used in the event of an emergency; and

**WHEREAS,** the borough applied for a State Homeland Security Program grant to purchase portable radios for the Anchor Point Fire & Emergency Medical Service Area (APFEMSA) as well as travel costs to attend the 2016 Alaska Shield planning and training events; and

**WHEREAS,** award notification for funds in the amount of \$51,114.00 has been received from the Alaska Division of Homeland Security and Emergency Management; and

**WHEREAS,** award funds in the amount of \$43,430.00 will be used to purchase portable radios for APFEMSA; and

**WHEREAS,** award funds in the amount of \$7,684.00 will be used to reimburse eligible costs associated with the 2016 Alaska Shield planning and training events; and

**WHEREAS,** at its meeting of September 9, 2015, the APFEMSA Board recommended approval; and

**WHEREAS,** it is in the best interests of the borough to accept these funds;

**NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:**

**SECTION 1.** That the mayor is authorized to accept \$51,114.00 from the State of Alaska Department of Military and Veteran Affairs, Division of Homeland Security and Emergency Management.

**SECTION 2.** That grant funds are appropriated to the following accounts:

- Funds in the amount of \$43,430.00 are appropriated to 271.51410.16HSP.49999 to purchase radios for APFEMSA.
- Funds in the amount of \$7,684.00 are appropriated to 271.11250.16HSP.49999 to reimburse eligible costs associated with the 2016 Alaska shield planning and training events.

**SECTION 3.** That the mayor is authorized to execute a grant agreement and any other documents deemed necessary to accept and expend the grant, and to fulfill the intents and purposes of this ordinance.

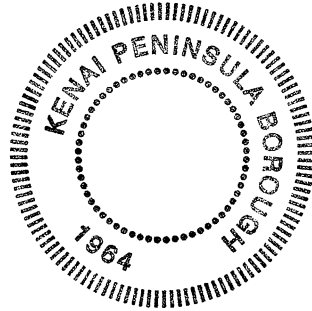
**SECTION 4.** This ordinance shall become effective immediately upon its enactment.
