**KENAI PENINSULA BOROUGH
ORDINANCE 2023-19-49**

AN ORDINANCE ACCEPTING AND APPROPRIATING GRANT FUNDS FROM SOUTHERN REGION EMERGENCY MEDICAL SERVICES, INC. ON BEHALF OF CENTRAL EMERGENCY SERVICES AND APPROPRIATING CENTRAL EMERGENCY SERVICE AREA OPERATING FUND BALANCE TO PROVIDE LOCAL MATCH FUNDS FOR FY2022 AND FY2024 ALASKA CODE BLUE GRANTS

WHEREAS, the Central Emergency Service Area (“CES”) applied for State of Alaska Code Blue Grants through Southern Region Emergency Medical Services Council, Inc. (“Southern Region”) in FY2022 and FY2024; and

WHEREAS, CES received notification March 5, 2024 that Southern Region approved the applications for partial funding and funded \$14,000 and \$9,450 respectively for the two grant applications; and

WHEREAS, this leaves a remaining balance due totaling \$24,714.76 which includes the required local match, administrative service fee, as well as the unmet portion; and

WHEREAS, the Central Emergency Service Area Board, at its meeting of April 18, 2024, recommended approval of this ordinance;

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

SECTION 1. That the Mayor is hereby authorized to enter into an agreement with the Southern Region Emergency Medical Services, Inc. and execute all other documents deemed necessary to accept the grant funds and fulfill the intents and purposes of this ordinance.

SECTION 2. Grant funds of \$14,000 are appropriated to the Central Emergency Service Area Operating Fund Balance to account 211.51610.22SR1.49999 for the purchase of six infusion devices.

SECTION 3. Grant funds of \$9,450 are appropriated to the Central Emergency Service Area Operating Fund Balance to account 211.51610.24SR1.49999 for the purchase of chest compression devices.

SECTION 4. Local funds of \$22,021.41 and \$2,877.05 are appropriated from the Central Emergency Service Area Operating Fund Balance to accounts 211.51610.22SR1.49999 and 211.51610.24SR1.49999 respectively for the purchase of chest compression devices and infusion devices.

SECTION 5. That appropriations made in this ordinance are of a project length nature and as such do not lapse at the end of any particular fiscal year.

SECTION 6. This ordinance shall be effective immediately.
