Late filing of Senior Citizen Exemption application

Our home is held in both my wife's and my name (We are ages 71 & 70 respectively). Apparently the original Senior Citizen Exemption was filed in my wife's name.

This resulted in our exemption being denied due to the circumstance that she was out of the state for more than 180 days this past year resulting in her PFD being denied (mine was not).

The reason she exceeded the 180 day requirement was to provide care for her terminally ill father. There is an exception allowing for absence for that reason but it is not in addition to the 180 day limit.

That of course doesn't make any sense, but the wording of the statute stands, apparently the legislature inadvertently used the word "and" instead of "or" when drafting the statute.

Anyway, the KPB apparently goes by only the status of the original applicant for purposes of allowing the Senior Exemption even though we are both qualified by age. If we had somehow known of that fact I would have of course, refiled in my name in a timely manner.

In conclusion, I am filing late for the above reasons. The whole sequence of events seems extraordinary to me but it's not my call.
