I appreciate your service. The matter of taxing groceries (non-prepared food) should be a settled matter. The voters have spoken many times. And, you serve at the pleasure of the voters.

About funding to the schools. KPB funded to the cap for many years. However, the School District has been abusing our generosity as you will see below. These numbers are retrieved from the KPBSD FY2013 Cafr. While the numbers do not tell the whole story they are very important. It is always a good practice to FOLLOW THE MONEY!!

For instance.

Property tax revenue has increased more than \$4-million in the last 3 years. Sales tax revenue has increased almost \$2-million during that time. This trend is likely to continue thru increased prices of consumer goods and property tax assessments.

Borough spending on Education has increased \$3-million even though KPB did not fund to the cap. The only discernable reduction in spending was for Roads and Trails of almost \$3-million. **We have plenty of money** and now we have plenty of debt also which is up over \$15-million. Granted we voted for the bonds, but government growth from debt is a disaster. Now the State of Alaska is likely to reduce their participation in our debt.

As our elected money managers you must be better stewards of our finances. I suggest you further reduce the Education contribution by another \$3.5-million until they demonstrate their ability to control their budget. Giving them more money at this time will only continue their bad budgetary behavior.

Your leadership must actually result in economic growth for the citizens of the KPB. You must say no to increases in spending and/or debt.

Therefore I suggest do not reduce the number of months where tax on food is levied. I strongly suggest you make the tax exemption year 'round and leave more money for the citizens.
