**SUBJECT:** Authorization to Award Contract for ITB16-031 2016 Capital Improvement Project – Greenfield Drive, Newbury Avenue & Starlight Street

The Purchasing and Contracting Office formally solicited and received bids for the ITB16-031 2016 CIP – Greenfield Drive, Newbury Avenue & Starlight Street. Bid packets were released on April 1, 2016 and the Invitation to Bid was advertised in the Peninsula Clarion on April 1 and 13, 2016 and in the Homer News April 6, 2016.

Project consists of furnishing all labor, materials, and equipment to upgrade these roads. Work includes but is not limited to roadbed widening, subgrade modification, embankment construction, drainage, ditching and clearing.

On the due date of April 20, 2016, six (6) bids were received and reviewed to ensure that all the specifications and delivery schedules were met. The low bid of \$247,321.25 was submitted by JC Johnson & Sons of Anchor Point, Alaska. The total costs for this project are \$321,782.47, which includes design services, contract services, inter-departmental charges, and contingencies.
