**KENAI PENINSULA BOROUGH
ORDINANCE 2022-19-41**

**AN ORDINANCE APPROPRIATING \$250,000 FROM THE GENERAL FUND FOR
REMEDIAION WORK AT THE NANWALEK LANDFILL AND REMOVAL OF
WASTE FROM NANWALEK AND PORT GRAHAM**

WHEREAS, both the Nanwalek Landfill and Port Graham Landfill are owned and permitted through the Kenai Peninsula Borough (“Borough”), with Port Graham being operated by a contractor and Nanwalek being operated by the Village of Nanwalek; and

WHEREAS, in 2020 when the COVID-19 Pandemic occurred, the Borough was not allowed access to these communities for a significant period of time; and

WHEREAS, in the summer of 2022 the Borough was able to complete site inspections with a representative from the Alaska Department of Environmental Conservation (“ADEC”); and

WHEREAS, while the Port Graham Landfill has been well maintained, the Nanwalek Landfill has fallen into poor condition and, as a result, the Borough has been directed by ADEC to complete remediation work to return it to an operable condition; and

WHEREAS, both of these sites are in need of removal of inert waste, recyclables and hazardous wastes from the sites that hasn’t been completed for several years; and

WHEREAS, the Nanwalek landfill the scope of work will include, rework and compaction of the existing waste cell, import and placement of cover material, removal of inert waste, removal and processing of hazardous waste, reestablishment of the waste disposal cell and all barge transport costs; and

WHEREAS, the Port Graham landfill the scope of work will include hauling out inert waste, recyclables, hazardous waste and old automobiles;

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

SECTION 1. That \$250,000 is appropriated from the General Fund fund balance to be transferred to account 290.32570.23SIT.43011 to provide supplemental funds to complete the Nanwalek landfill and Port Graham landfill site work.

SECTION 2. That appropriations made in this ordinance are project length in nature and as such do not lapse at the end of any particular fiscal year

SECTION 3. That this ordinance shall be effective immediately upon enactment.
