Amend the sixth Whereas clause to read, "while the revenue to the borough generated from this additional sales tax on temporary lodging would be used solely for educational purposes, it would make other borough revenues available to offset these visitor costs and help maintain the fund balance; and"

Amend the ninth Whereas clause to read, "to enable the cities to levy a similar tax and allow the tax to apply evenly throughout the borough, the ordinance exempts from the borough's 12 percent temporary lodging tax an amount equal to a similar [ADDITIONAL] city tax up to 6 percent; and"

Add a new tenth Whereas clause immediately preceeding the final Wherea clause to read, "this also specifically authorizes cites to levy a temporary lodging tax to ensure the general law cities may do so under AS 29.45.700(a) even though the borough exempts temporary lodging from its general sales tax; and"

Amend Section 1 to read. "KPB 5.18.100 is amended as follows:

5.18.100. General-Levied-Amount.

...

C. In addition to the sales taxes levied by the borough, any municipality within the borough may levy a consumer's sales tax [AND] including a temporary lodging tax that may be included in their general sales tax, taxed separately or both, as provided by Alaska Statute which shall be reported, collected, and enforced according to the terms of this chapter."

Amend Section 3 to read, "That KPB 5.18.215 is hereby enacted as follows:

5.18.215. Exemptions/waivers-Temporary lodging within cities in the borough.

Rentals of temporary lodging within any city in the borough are exempt from the portion of the borough's temporary lodging tax in an amount equal to the amount of a similar [SEPARATE] temporary lodging tax that may be levied by a city, up to a maximum exemption of one-half of the borough's temporary lodging tax."

Amend Section 4 to read, "That a ballot proposition shall be placed before borough voters at the regular election on October 2, 2018 to read as follows:



Shall Ordinance 2018-24, [PROVIDING FOR THE EXEMPTION OF] exempting temporary lodging from the general sales tax, [THE LEVY OF A TAX ON TEMPORARY LODGING] providing for a sales tax of up to 12 percent [OF THE RENTAL PRICE] on temporary lodging, and, in any city [IN THE BOROUGH] that taxes [LEVIES A SIMILAR ADDITIONAL] temporary lodging [TAX], [GRANTS AN EXEMPTION OF] exempting from the borough tax an amount equal to the city's temporary lodging tax[,] up to a maximum of one-half of the borough's temporary lodging tax be approved?[,] "Temporary lodging" means "a service to provide any lodging of less than one month".

Yes \_\_\_\_ A "yes" vote means you approve of a [TAX ON] borough temporary lodging tax of up to 12 percent [of the rental price in the borough] instead of the general sales tax on temporary lodging, with an exemption in any city that levies a [SIMILAR ADDITIONAL] temporary lodging tax of an amount equal to the city's tax. This exemption [IS UP TO A MAXIMUM OF] in cities cannot exceed one-half of the borough's temporary lodging tax.

No \_\_\_\_ A "no" vote means you oppose a borough tax on temporary lodging of up to 12 percent [OF THE RENTAL PRICE IN THE BOROUGH] instead of the general sales tax, with an exemption in any city that levies a [SIMILAR ADDITIONAL] temporary lodging tax of an amount equal to the city's tax. Amend the title to read, "AMENDING KPB 5.18.200 TO AMEND THE SEASONAL EXEMPTION FROM SALES TAXES OF NONPREPARED FOOD ITEMS TO APPLY FROM OCTOBER 1 TO MARCH 31 OF EACH YEAR SUBJECT TO VOTER APPROVAL"

Amend the sixth Whereas clause to read, "changing the exemption period to coincide with typical quarterly filing periods will help the sellers administer the exemption; and"

Add a new seventh Whereas clause immediately following the sixth Whereas clause to read, "as the voters first approved this exemption by initiative it is appropriate to seek voter approval to amend it, and;"

Amend Section 2 to read, "That [THIS ORDINANCE SHALL TAKE EFFECT

SEPTEMBER 1, 2018] a ballot proposition shall be placed before borough voters at the regular election on October 2, 2018 to read as follows:

Shall Ordinance 2018-20, amending KPB 5.18.200 to amend the seasonal exemption from sales taxes of nonprepared food items to apply for six months, from October 1 to March 31 of each year instead of for nine months, from September 1 until May 31, be approved?

Yes A "yes" vote means you approve of amending the seasonal sales tax exemption of nonprepared food Items to apply for six months, from October 1 to March 31 of each year. Instead of for nine months, from September 1 until May 31 of each year.

No A "no" vote means you oppose amending the seasonal exemption of nonprepared food items from sales taxes to apply for six months, from October 1 to March 31 of each year. Instead of for nine months, from September 1 until May 31 of each year."

Add a new Section 3 to read, "That Sections 2 and 3 of this ordinance shall take effect immediately upon its enactment. Section 1 of this ordinance shall take effect April 1, 2019 only If the proposition contained in Section 2 of this ordinance is approved by a majority of voters voting on the question in the regular election on October 2, 2018."
