SUBJECT: 2015 Over-The-Counter Land Sale Information
In 2014 Land Management conducted two land sales and sold a total of fourteen parcels. Eleven of fifteen parcels in the borough's 2014 Sealed Bid General Land Sale had successful bids. Three of twenty-three lots in the Widgeon Woods Land Sale received successful bids. Parcels not sold were authorized for an Over-The-Counter Land Sale beginning January 5, 2015 and ending September 30, 2015 pursuant to Ordinances 2014-16 and 2014-17. Twenty-four parcels are available to be included in, the over-the-counter sale.

Section two of each ordinance provides that the sale price for parcels offered over-thecounter may be reassessed and readjusted to reflect the latest market value provided such adjustments are reported to the assembly at the regularly scheduled meeting of December 9, 2014. Based on a review of the preliminary 2014 sale results, Land Management will not be adjusting the sale prices for parcels offered in the 2015 Over-The-Counter Sale. An Over-The-Counter Land Sale brochure will be available on the borough's Land Management webpage later this week in preparation of the January 5, 2015 starting date. Enclosed is a copy of the news ad notifying the public of the opportunity to participate in the upcoming land sale.
