NOTICE IS HEREBY GIVEN that the Kenai Peninsula Borough Assembly will conduct public hearing on **Tuesday, March 17, 2015** at 6:00 p.m., or as soon thereafter as business permits in the Borough Assembly Chambers located at 144 N. Binkley Street, Soldotna, to receive public testimony on <u>Ordinance 2014-35</u>: Approving the Diamond Willow-Fairfield Single-Family Residential R-1 Local Option Zoning District, and Amending KPB 21.46.040.
