## A RESOLUTION RECOGNIZING PROJECTS COMPLETED UNDER THE U.S. FISH & WILDLIFE SERVICE, COASTAL IMPACT ASSISTANCE PROGRAM AND REDIRECTING FUNDS TO THE RECREATION AREA SANITATION PROJECT

- WHEREAS, the Coastal Impact Assistance Program (CIAP) was established under Section 384 of the Energy Act of 2005 and authorizes the Secretary of the Interior to disburse funds to Outer Continental Shelf oil and gas producing states; and
- WHEREAS, the purpose of the CIAP is to provide funding through a non-competitive grant process to oil and gas producing states to mitigate the effects of offshore oil and gas activities; and
- **WHEREAS**, the borough received 15 CIAP project awards as adopted by Resolution 2009-018, approved in the Alaska Department of Natural Resources State Plan and awarded through CIAP; and
- WHEREAS, the Flood Plain Development Survey Benchmarks project, as approved through Ordinance 2010-19-43, was closed with a balance of \$12,360.00; and
- WHEREAS, the Aerial Photography Satellite Imagery project, as approved through KPB Ordinance 2010-19-48, has been completed, with a remaining balance of \$38,531.35; and
- WHEREAS, the Habitat Protection Education and Code Revision project, identified as the Kenai Peninsula Borough Code Review in the 2009-2010 project list, as approved through Ordinance 2010-19-27, has been completed, with a remaining balance of \$40,645.25; and
- WHEREAS, funds in the amount of \$91,536.70 are available to be redirected to other projects that were adopted by Resolution 2009-018; and
- WHEREAS, the borough applied for and received a second amendment in the amount of \$91,322.72 from U.S. Fish & Wildlife Service to increase the Recreation Area Sanitation Project to \$160,594.72;

NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

**SECTION 1.** That the mayor is authorized to redirect the U.S. Fish & Wildlife Service, Coastal Impact Assistance Program funds from the following completed projects to the Recreation Area Sanitation Project:

Funds in the amount of \$12,360.00 from the Flood Plain Development Survey Benchmarks project account number 271.21135.11097.49999; and

Funds in the amount of \$38,531.35 from the Aerial Photography Satellite Imagery project account number 271.21135.11124.49999; and

Funds in the amount of \$40,431.37 from the Habitat Protection Education and Code Revision project account number 271.21135.11002.49999.

**SECTION 2.** That grant funds totaling \$91,322.72 are hereby redirected to the Recreation Area Sanitation Project account number 271.21135.11051.49999.

**SECTION 3.** That this resolution takes effect immediately upon its adoption.
