**A RESOLUTION SUPPORTING THE APPROPRIATION OF \$12,000
FROM THE ROAD SERVICE AREA FUND TO SUPPORT THE
PREMILLINARY ENGINEER'S ESTIMATES FOR FY19 PROPOSED
ROAD IMPROVEMENT ASSESSMENT DISTRICT**

WHEREAS, each fiscal year the Kenai Peninsula Borough Road Service Area budgets funds to support the preliminary engineer's estimates that are required for proposed road improvement assessment districts ("RIAD"); and

WHEREAS, during the FY19 annual budgetary process, due to an oversight, no funds were appropriated for this purpose; and

WHEREAS, there are currently two RIADs being proposed and approximately \$12,000 is needed to support the currently proposed RIADs engineer's estimates as well as the remaining projects for the fiscal year; and

WHEREAS, the ordinance to appropriate funds to support the preliminary engineer's estimates for proposed RIAD was introduced by the Kenai Peninsula Borough Assembly at its August 7, 2018 meeting.

**NOW, THEREFORE, BE IT RESOLVED BY THE KENAI PENINSULA BOROUGH
ROAD SERVICE AREA BOARD**

SECTION 1. The RSA board recommends the appropriation of \$12,000 from the Road Service Area Fund to support the Preliminary Engineer's Estimates for FY19 proposed Road Improvement Assessment District.

SECTION 2. That a copy of this resolution shall be forwarded to the mayor and the assembly.
