**KENAI PENINSULA BOROUGH
ORDINANCE 2022-19-51**

**AN ORDINANCE ACCEPTING AND APPROPRIATING FEDERAL PASS THRU
GRANT FUNDS OF UP TO \$43,350 TO THE KENAI PENINSULA BOROUGH TO
DEVELOP A DRAINAGE PLAN FOR GRAVEL PIT CLEAN DISCHARGE IN THE
BIG EDDY AREA**

WHEREAS, the Alaska Clean Water Actions (“ACWA”) grant program is administered by the Alaska Department of Environmental Conservation (“ADEC”), who sets priorities for water quality, habitat, and quantity issues statewide; and

WHEREAS, the Kenai Peninsula Borough (“Borough”) Planning Department applied for and was selected to receive an ACWA grant to develop an area drainage plan in response to highwater concerns along Greenridge Street (the Project); and

WHEREAS, the Project is will result in a recommendation to better address stormwater runoff affecting Borough assets; and

WHEREAS, this award is contingent on funds being available from the Environmental Protection Agency and Legislative authorization; and

WHEREAS, the State of Alaska will reimburse the Borough up to \$43,350 to implement the Project, contingent upon fund availability;

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

SECTION 1. That the Mayor is authorized to accept grant funds in the amount of up to \$43,350 from the Alaska Department of Environmental Conservation to develop a clean water stormwater discharge plan, and is authorized to execute all documents deemed necessary to accept the grant.

SECTION 2. That pass thru grant funds in the amount of up to \$43,350 are appropriated from the General Fund fund balance to 100.21110.23EPB.49999 for eligible activities under the Alaska Clean Water Actions grant.

SECTION 3. That the appropriations made in this ordinance are of project length nature and as such do not lapse at the end of any particular fiscal year.

SECTION 4. That this ordinance shall be effective immediately upon enactment.
