The Purchasing and Contracting Office formally solicited and received bids for the Forest Road Bridges Repair. Bid packets were released on September 24, 2015 and the Invitation to Bid was advertised in the Peninsula Clarion on September 24, 28 & October 1, 2015 and Seward Journal on October 1, 2015.

The project consists of repairing bridges on Forest Road in the Old Mill Subdivision. Seward.

On the due date of October 8, 2015 three (3) bids were received and reviewed to ensure that all the specifications and delivery schedules were met. The low bid of \$89,570.00 was submitted by Metco, Inc., 2701 Seward Highway, Seward, AK. The total costs for this project are \$116,840.00, which includes design services, contract services, inter-departmental charges, and contingencies.

The Kenai Peninsula Borough Assembly approved through Fiscal Year 2015 Budget Forest Road Bridges Repair #E3FRB Capital Improvement Project. This project has been approved through Road Service Area Resolution 2014-10.
