A RESOLUTION AUTHORIZING THE ACQUISITION BY DONATION OF REAL PROPERTY ON BEHALF OF THE SEWARD-BEAR CREEK FLOOD SERVICE AREA LOCATED IN THE EAST HALF OF U.S. SURVEY NO. 722 MORE PARTICULARLY DESCRIBED IN DOCUMENT NO. 2004-001665-0, SEWARD RECORDING DISTRICT

- **WHEREAS**, the Seward-Bear Creek Flood Service Area (SBCFSA) provides for flood protection, planning and mitigation services within the service area boundary; and
- WHEREAS, the owner of the east half of U.S. Survey No. 722 more particularly described in Document No. 2004-001665-0, Seward Recording District has offered to donate the land, which is within the SBCFSA, to the borough; and
- **WHEREAS**, the property is mostly classified under FEMA's DFIRM as Flood Hazard Zone AE; and

SECTION 1. That the acquisition of the following described real property on behalf of the Seward-Bear Creek Flood Service Area is in the best interests of the Borough:

That portion of land located in the east half of U.S. Survey No. 722 more particularly described in Document No. 2004-001665-0, Seward Recording District (Assessor Parcel No. 145-022-22).

- **SECTION 2.** That the terms and conditions substantially in the form of the Purchase Agreement accompanying this resolution are hereby approved. The purchase price shall be one dollar (\$1.00) plus closing costs not to exceed five hundred dollars (\$500).
- **SECTION 3.** That this acquisition is for flood protection and mitigation purposes.
- **SECTION 4.** That the proposed classification of this land is government.
