**A RESOLUTION COMMENDING ROBIN JOHNSON & CIPRIANA CASTELLANO;  
WORLD CHAMPIONS IN THE CLASSICS POWERLIFTING WORLD  
CHAMPIONSHIP COMPETITION**

**WHEREAS**, the World Championship Powerlifting Competition was held in Salo, Finland on June 5 -14, 2015; and

**WHEREAS**, powerlifting is a barbell sport consisting of the squat, bench press, and deadlift, where each competitor gets three attempts at each lift, with the best of each lift contributing to the competitor's total score; and

**WHEREAS**, powerlifting is (WADA) World Anti-Doping Agency compliant and participates in the (IOC) International Olympic Committee recognized World Games; and

**WHEREAS**, at the recently completed Classics Powerlifting World Championship Competition, two Kenai Peninsula High School students', Robin Johnson a junior at Soldotna High School and Cipriana Castellano a senior at Kenai Central High School, won their divisions and are now World Champions; and

**WHEREAS**, Robin Johnson is 16 years old and won the sub junior (teen) division in the-158 pound body weight class squatting 341 pounds, bench pressing 176 pounds, and deadlifting 347 pounds; and

**WHEREAS**, Cipriana Castellano is 17 years old and won the sub junior (teen) division in the -185 pound body weight class squatting 336 pounds, bench pressing 181 pounds, and deadlifting 380 pounds; and

**WHEREAS**, 800 athletes from other countries: Russia, Poland, South Africa, Finland, Iceland, Canada and Great Britain participated at the International Powerlifting Federation RAW Classics Powerlifting World Championships in Salo, Finland;

**NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:**

**SECTION 1.** The Kenai Peninsula Borough Assembly commends Robin Johnson and Cipriana Castellano for their hard work and dedication to the sport of powerlifting and becoming World Champions in the Classic Power Lifting World Championship Competition.
