Amend the 3rd Whereas clause to read:

"WHEREAS, the mayor has proposed school funding from local sources for FY2026 [is proposed] to be \$57,634,015; and"

Add a 4th Whereas clause to read:

**"WHEREAS, per AS 14.17.410, the Borough's minimum required local contribution toward public school funding for FY2026 is \$35,537,970 and the maximum local contribution for FY2026 is \$62,359,080; and"**

Add a 5th WHEREAS clause to read:

**“WHEREAS, the purpose of this resolution is to set the Borough's local contribution floor not set the final local contribution amount, the total local contribution funding for school purposes will be determined during the annual budget process; and”**

Amend Section 2 to read:

**"SECTION 2.** That **a minimum of** \$57,634,015 shall be made available from local sources to fund school district operations for Fiscal Year 2026 as follows:

...”
