

**EXHIBIT D**  
**MEMORANDUM OF AGREEMENT FOR**  
**MOBILE HEALTH SERVICES**

This Memorandum of Agreement is made between Central Peninsula General Hospital, Inc. ("CPGH") and the Kenai Peninsula Borough ("KPB"), on behalf of Nikiski Fire Service Area ("NFD"), to set forth the terms and conditions for the transfer of Nikiski Fire's Mobile Integrated Health ("MIH") program to CPGH to allow for integrated, comprehensive mobile crisis response within the Central Kenai Peninsula Hospital Service Areas as follows:

1. Transfer of vehicle asset. Subject to the State's approval of 24MIH grant changes, KPB will transfer the vehicle, a Ford Explorer, purchased with grant funds to CPGH for the purpose of utilizing the MIH vehicle to satisfy the objectives of the program and will enable the mobile crisis team to respond swiftly to crisis, providing critical support to the community and reinforcing the NFD's emergency response efforts. Once any assets transferred are determined to be no longer needed or require disposal, CPGH will notify the KPB prior to disposal and the KPB will facilitate communications with the granting agency for disposal instructions.
2. Use of Space NFD, Station 3. CPGH will be charged, at cost and proportional, actual costs of its use of space for all direct costs incurred as part of the MIH program, such as but not limited to utilities, internet, grounds maintenance, etc. This will allow the mobile crisis team to effectively respond to calls, increase personnel safety, and ensure that Nikiski fire Service Area costs related to the MIH program are covered.
3. CPGH is required to provide a grant report representing a request for reimbursement in the prescribed format along with detailed source documentation no later than the 10<sup>th</sup> of January, April, July, and October for the preceding quarter. This report will be electronically provided to the KPB Grants Administrator and Community Liaison at: [Ehardie@kpb.us](mailto:Ehardie@kpb.us). All requests for reimbursement must be for services provided within the Nikiski Fire Service Area through the grant expiration term of May 31, 2025.

4. Beyond the grant reporting requirements herein, CPGH may, but is not obligated to provide any services pursuant to this Agreement, and may cease to provide any services previously provided at any time pursuant to this Agreement. Both KPB and CPGH may terminate this Memorandum of Agreement for Mobile Health Services within 30 days written notice, with or without cause.
  
5. It is the parties' intent that all promises, covenants, agreements, terms and conditions of the Operating Agreement between CPGH and KPB remain in full force and effect and this Memorandum of Agreement is not intended to vary the terms of the Operating Agreement.
