The Purchasing and Contracting Office formally solicited and received bids for the ITB16-024 #N1CHE Cherry Lane. Bid packets were released on February 18, 2016 and the Invitation to Bid was advertised in the Peninsula Clarion on February 18, 2016.

The project consists of furnishing all labor, materials, and equipment to upgrade these roads. Work includes roadbed widening, subgrade modification, drainage, ditching and clearing.

On the due date of March 16, 2016 seven (7) bids were received and reviewed to ensure that all the specifications and delivery schedules were met. The low bid of \$106,769.00 was submitted by Wolverine Supply Inc, Wasilla, Alaska. The total costs for this project are \$142,785.00, which includes design services, contract services, inter-departmental charges, and contingencies.
