SUBJECT: Authorization to Award Contract for North Peninsula Recreation Center Pool Tile and Drain Replacement

The Purchasing and Contracting Office formally solicited and received bids for the North Peninsula Recreation Center Pool Tile and Drain Replacement. Bid packets were released on 7/31/2015 and the Invitation to Bid was advertised in the Peninsula Clarion and Alaska Dispatch News on 7/31/2015.

The project consists of removal and replacement of approximately 2,100 square feet of floor tile, approximately 100 lineal feet of coved tile base, approximately 200 square feet of ceramic wall tile and approximately 34 lineal feet of trench drain.

On the due date of 8/19/2015 four (4) bids were received and reviewed to ensure that all the specifications and delivery schedules were met. The low bid of \$99,700.00 was submitted by Arctic Exterior Solutions, Anchorage, AK
