**KENAI PENINSULA BOROUGH  
ORDINANCE 2011-27**

**AN ORDINANCE ABOLISHING THE LOWELL POINT EMERGENCY SERVICE  
AREA, REPEALING KPB CHAPTER 16.45, AND PROVIDING FOR THE  
SUBMISSION TO THE SERVICE AREA VOTERS OF A PROPOSITION  
APPROVING THE ABOLISHMENT OF THIS SERVICE AREA**

**WHEREAS**, the Lowell Point Emergency Service Area (“LPESA”) was established in Ordinance 2003-03 by the Kenai Peninsula Borough Assembly and approved by the voters of the service area to provide emergency services to the community of Lowell Point on the eastern Kenai Peninsula immediately south of the city of Seward; and

**WHEREAS**, the LPESA encompasses the Lowell Point area on the eastern Kenai Peninsula immediately south of the City of Seward; and

**WHEREAS**, the Lowell Point Volunteer Fire Department was in existence prior to the establishment of the LPESA and the members expect that it will continue if the the LPESA is dissolved; and

**WHEREAS**, this small community is in need of volunteers and the members of the board of directors are precluded from being members of the Lowell Point Volunteer Fire Department as they would have conflicting interests; and

**WHEREAS**, the rates levied by the Kenai Peninsula Borough for insurance coverages including Workers Compensation consume a substantial portion of the service area budget; and

**WHEREAS**, the community of Lowell Point established a non-profit corporation, Lowell Point Community Council, Inc. which was working towards providing fire protection services in the Lowell Point area before formation of the service area; and

**WHEREAS**, the community currently provides for the emergency needs of the area through the Lowell Point Community Council; and

**WHEREAS**, the Lowell Point Community Council is eligible for funds through the Community Revenue Sharing Program; and

**WHEREAS,** Alaska Statute 29.35.450(c) requires that the abolishment of a service area that provides fire protection services must be approved by the majority of the voters residing in the service area who vote on the question; and

**WHEREAS,** at its meeting of June 14, 2011 the Lowell Point Emergency Service Area Board adopted LPESA Board Resolution 2011-084 supporting dissolution of the Lowell Point Emergency Service Area;

**NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:**

**SECTION 1.** That KPB Chapter 16.45, Lowell Point Emergency Service Area, is hereby repealed and the service area is abolished.

**SECTION 2.** That a ballot proposition shall be placed before Lowell Point Emergency Service Area voters at the next regular election to read as follows:





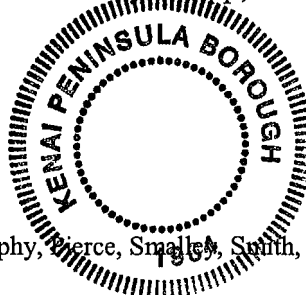
**SECTION 3.** That section 2 of this ordinance takes effect immediately upon its enactment, and section 1 shall take effect July 1, 2012 if the ballot proposition in section 2 is approved by a majority of the voters voting on the question.
