**KENAI PENINSULA BOROUGH
ORDINANCE 2014-19-46**

**AN ORDINANCE APPROPRIATING \$20,000 FROM THE BOROUGH'S GENERAL
FUND TO THE BOROUGH'S UNIFORM ADDRESS SIGN PROJECT FOR
ADDITIONAL FUNDING NEEDED TO START THE 2015 PROJECT PRIOR TO THE
2016 FISCAL YEAR**

- WHEREAS**, the Kenai Peninsula Borough facilitates a Uniform Address Number Sign Program to enhance delivery of emergency services to the residents of the borough; and
- WHEREAS**, this program runs seasonally during the summer months while the ground is thawed, usually beginning in May and continuing until winter freeze up; and
- WHEREAS**, this does not coincide well with fiscal year budgeting as the project year begins before the new fiscal year begins, which often requires waiting until July 1st to start the project and drastically reduces the time available to post the current year's requested address signs; and
- WHEREAS**, two unincorporated communities within the Kenai Peninsula Borough are chosen for the scope of the project area each calendar year; and
- WHEREAS**, costs associated with larger communities have exceeded the yearly budgeted amount for the program which has led delaying the project until after July 1 when funds are available for the next fiscal year; and
- WHEREAS**, a \$20 per sign fee is charged for the installation and \$17,900 in such fees were collected from the public in 2014; and
- WHEREAS**, the 2014 project was suspended before completion due to insufficient funds and the winter freeze up occurring before all signs could be posted, resulting in a long delay for some of the people who have paid their fee; and
- WHEREAS**, additional funding of \$20,000 is needed to finish the 2014 project year and begin the 2015 project year to allow full utilization of the seasonal time available to complete a project year;

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

SECTION 1. That \$20,000 is appropriated from the borough's General Fund, fund balance to account number 100.21110.15SGN.42020 Uniform Address Number Sign Program.

SECTION 2. That this ordinance takes effect immediately upon its enactment.
