As it turns out, Spenard is its own town in November of 1964 when I become a resident of the state of Alaska. Mom and Dad drive into Anchorage to a real hospital at the corner of 9th and L Street on the outskirts of downtown Anchorage, to have their second son.

Leaving Spenard, the family moves through bush Alaska following my father from RCA contract installations site to site living in Kodiak, Ketchikan, and Bethel; eventually buying property with a cabin in Tok to build a home. Following Tok, the next stop is Auk Bay outside Juneau before heading to Anchorage via Tok once again.

Growing up in the Rogers Park neighborhood in Anchorage includes an elementary school named for the subdivision, Wendler Jr. High School and on to East Anchorage High School and expanded training in communication design at the King Career Center. An audition for the Anchorage Youth Symphony, while at Wendler, wins a place in the orchestra; which later, while on a south central concert tour, introduces me to the Kenai Peninsula with a stay at the newly completed but vacant Skyview High School.

While studying Journalism and Public Communication at UAA, a recruiter calls offering college money for joining a new unit formed on Elmendorf Air Force Base with funds provided by Senator Ted Stevens.

It turns out Recruit Daly is the first new recruit to sign up for Echo Company 4th Reconnaissance Battalion 4th Marine Division, USMCR. After completing Basic Training in San Diego and Field Radio Operator School in 29 Palms, CA a number of opportunities present themselves to become fully MOS proficient including US Navy SCUBA School, US Army Airborne School, USMC Water Safety Survival School, USMC Scout Swimmer School, USMC Reconnaissance Patrol School. While with E Co. we put together a stick, a parachute jump team. The unit represents Alaska Marines in the Special Forces Parachute Jump Competition held in Rhode Island. Germany wins: Dang it.

A job in professional wholesale sales after college gives the opportunity to work with clients in locations around the state. Businesses in Fairbanks, Dillingham, Western Auto in Seward, Rollin Baden's Riverside Auto Parts in Soldotna, Dave Jewell's Frontier Auto in Kenai, Jerry Wortham's first Alyeska Tire location, John Mellish's RPM's Automotive Machine Shop on Kalifornsky Beach Road, Ken Rice's Nkiiski Shop as well as the B&C stores in Homer; all become familiar. Dave Jewell shows me how salmon fishing is done on the Kenai after work one day and for me the peninsula blooms with possibilities.

As technology explodes a move to a new industry and a position with the largest independent business technology dealer provides an opportunity to put all the experience to work. My work ethic leads Frontier Business Machines in sales for the next three years. As office equipment shifts from analogue platforms to digital Ikon Office Solutions, a Fortune 500 company needs a digital and color special and a lateral move introduces me to a company location in Kenai drastically in need of help. January of 1998 the opportunity to run my own show and live on the Kenai Peninsula is too good to pass on, and I move to Kenai, followed three months later by my wife Mary and our two daughters Shelby and Austin.

Within six months it become clear there is a better way to do business on the Kenai Peninsula and on August 1st 1998 HiSpeed Gear, a full service independent Alaskan-owned business technology dealership is founded. The first digital copier sold by the company is installed at Bob Favretto's Kenai Chrysler Center and the first fax machine sold goes to Tim Wiznewski at Kenai Peninsula Memorial Chapel.

Volunteering in 2009 at a Kenai Cardinals swim meet calling heats and introducing athletes, leads to a conversation at a Rotary lunch with Matt Wilson and a follow up meeting that creates Tom Randell's Daly Show on Q 100.1 FM and a moderator position on KSRM's Sound Off.

Along the way opportunities in the Alaskan film industry qualify for a membership in SAG/ AFTRA and the opportunity to market the State of Alaska as a film production destination at AFCI annual show in LA.

Both daughters are graduates of Kenai Central High School. Shelby, our eldest, completed her BS at Pacific Lutheran and her Masters at California Baptist University. She is an athletic trainer at CalTech and the head athletic trainer for the Ontario Fury a professional soccer team. Austin, our youngest daughter, will graduate from PLU this spring with a double major in Spanish Language and International Studies with a minor in Anthropology. Mary, my wife, and I met in high school at a Youth Leadership Lock-in at St. Elizabeth Anne Seaton and have been dating ever since. Our 30th wedding anniversary will be in August of this year.

My parents David and Rose Marie Daly live in Homer just up the hill from the Spider House.
