**KENAI PENINSULA BOROUGH  
RESOLUTION 2016-011**

**A RESOLUTION AUTHORIZING COMMUNITY REVENUE SHARING PROGRAM  
EXPENDITURES FOR THE UNINCORPORATED COMMUNITY OF RAZDOLNA**

**WHEREAS**, the Alaska State Legislature has provided funding to municipalities and unincorporated communities through the Community Revenue Sharing Program (hereinafter referred to as “Program”); and

**WHEREAS**, AS 29.60.865 and 3 AAC 180.070 requires the assembly of a borough or unified municipality to adopt a resolution identifying those unincorporated communities located within their municipal boundaries that the assembly determines meet the Program eligibility criteria established under AS 29.60.865, AS 29.60.879, and 3 AAC 180.110; and

**WHEREAS**, the Program allows funds to be used for any public purpose at the discretion of the local governing body and as allowed by state statutes and borough code; and

**WHEREAS**, the assembly approved Razdolna as one of the 27 unincorporated communities within the Kenai Peninsula Borough that is eligible for participation in the State’s FY16 Program by way of Resolution 2015-010; and

**WHEREAS**, the assembly approved acceptance of Program funds and appropriated \$521,100 for the 27 unincorporated communities to a project contingency account through enactment of Ordinance 2015-19-07; and

**WHEREAS**, the Village of Razdolna is the nonprofit organization eligible to receive and complete public projects using FY16 funds in the amount of \$18,922; and

**WHEREAS**, the nonprofit originally requested to defer the funds, allowing them time to discuss projects to be completed; and

**WHEREAS**, the nonprofit is pursuing fencing an ice rink, installing street lights, and purchasing library books and laptops for students with the funds;

**NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:**

**SECTION 1.** That the Mayor is authorized to enter into a grant agreement and any other documents necessary to disburse the Community Revenue Sharing program funds for public projects to the unincorporated community of Razdolna.

**SECTION 2.** That the Village of Razdolna, a nonprofit organization representing the unincorporated community of Razdolna, shall enter into a grant agreement with the borough in the amount of \$18,922 prior to receipt of any revenue sharing funds.

**SECTION 3.** This resolution shall become effective immediately upon adoption.
