COMMENDING RESOLUTION**

**A RESOLUTION HONORING THE CENTRAL KENAI PENINSULA  
LEAGUE OF WOMEN VOTERS**

**WHEREAS,** founded in 1979, the Central Kenai Peninsula League of Women Voters has served the members of our community by promoting active and informed citizen participation in government through education and advocacy; and

**WHEREAS,** the Central Kenai Peninsula League of Women Voters monitors elections and government activities and provides nonpartisan, balanced information on local, state, and national issues; and

**WHEREAS,** the Central Kenai Peninsula League of Women Voters encourages citizen participation in the political process by facilitating voter registration, sponsoring candidate forums, and providing nonpartisan, balanced information to the public on local, state, and national issues; and

**WHEREAS,** the Central Kenai Peninsula League of Women Voters has long advocated for public policies that provide equal and quality voting rights, education, and health care for all, while minimizing the impacts on the environment; and

**WHEREAS,** this year, the Central Kenai Peninsula League of Women Voters continues to educate and engage the public and its elected representatives on issues ranging from nonpartisan redistricting, to voting protection, to the Equal Rights Amendment, to fair judicial representation, while encouraging community members of contrasting opinions to gather and learn from their differences to inspire connection and commutuality; and

**WHEREAS,** throughout its 42 years of service, the Central Kenai Peninsula League of Women Voters has worked assiduously to raise the level of informed political debate and promote reasoned public policy;

**NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:**

**SECTION 1.** That the Kenai Peninsula Borough Assembly hereby commends the Central Kenai Peninsula League of Women Voters on the occasion of its 42nd year of service.

**SECTION 2.** That the Clerk of the Kenai Peninsula Borough shall prepare a copy of this resolution for presentation to the Central Kenai Peninsula League of Women Voters as an expression of the Borough's admiration for its legacy of contributions to civic engagement within the Kenai Peninsula.


**SECTION 3.** That this resolution shall become effective immediately upon its adoption.

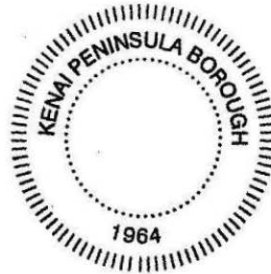
