**KENAI PENINSULA BOROUGH
ORDINANCE 2017-19-20**

**AN ORDINANCE AUTHORIZING THE PURCHASE AND IMPLEMENTATION OF
TOMOSYNTHESIS EQUIPMENT, SOFTWARE, INSTALLATION, AND TRAINING
AND APPROPRIATING \$587,100 FROM THE CPGH, INC. PLANT REPLACEMENT
AND EXPANSION FUND FOR THE PROJECT**

WHEREAS, the Kenai Peninsula Borough (“borough”) has entered into an Operating Agreement with Central Peninsula General Hospital, Inc. (“CPGH, Inc.”) for the operation of the Central Peninsula Hospital (“CPH”) and other medical facilities, to operate these medical facilities on a nonprofit basis in order to ensure the continued availability of the medical facilities to the service area residents and visitors; and

WHEREAS, to improve breast imaging capability and meet the needs of residents of the borough as well as supporting a comprehensive oncology program, CPGH, Inc. has negotiated the purchase of tomosynthesis equipment and software for \$587,100, which meets CPGH, Inc.’s needs to provide this service at the hospital; and

WHEREAS, this purchase is in line with the procedures in the Operating Agreement; and

WHEREAS, at its meeting of January 25, 2018, the CPGH, Inc. board of directors considered CPGH, Inc. Resolution 2017-72 and voted to approve the purchase of tomosynthesis equipment and software, including installation and training for a total cost of \$587,100, with the funds for payment to be made from the CPH Plant, Replacement and Expansion Fund;

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

SECTION 1. That \$587,100.00 is appropriated from the CPH Plant Replacement and Expansion Fund to account no. 490.81110.18TOM.49999 for the purchase of tomosynthesis equipment and software, including installation and training.

SECTION 2. That this ordinance takes effect immediately upon its enactment.

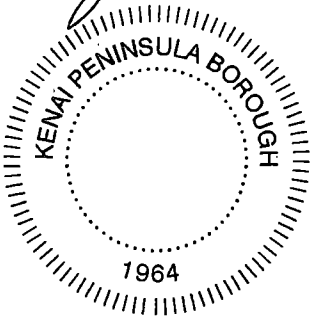
