On July 11, 2016 the Kenai Peninsula Borough Road Service Area formally solicited bids for Thurston Drive, Bradley Lane and Victor Drive Project No. S7THU for completion in October 2016. The invitation to bid was advertised in the Peninsula Clarion on July 11, 2016 and Homer News on July 14, 2016.

On the due date of July 21, 2016 two (2) bids were received and reviewed to ensure that all the specifications and delivery schedules were met. Attached is a copy of the bid tabulation sheet.

The lowest responsive bid was received from East Road Services, in the amount of \$281,504.50 The total cost for this project is \$360,672.10, which includes design services, contract services, interdepartment charges, and contingencies.

The Kenai Peninsula Borough Assembly approved through Fiscal Year 2016 Budget Capital Improvement Project, Thurston Drive, Bradley Lane and Victor Drive Project No. S7THU. This project has been approved through Road Service Area Resolution 2015-11 Approving Road Projects Be Included as Fiscal Year 2016 Capital Improvement Projects. Expenditures for the contract will be charged to account number 434.33950.S7THU.49999.
