RESOLUTION 2017-013**

**A RESOLUTION SUPPORTING KENAI MOUNTAINS-TURNAGAIN ARM
CORRIDOR COMMUNITIES ASSOCIATION EFFORTS TO PLAN AND DEVELOP A
NONMOTORIZED TRAIL ALONG THE HOPE HIGHWAY**

WHEREAS, the Kenai Mountains-Turnagain Arm Corridor Communities Association (“KMTA CCA”) fosters planning and partnerships among the communities within the Kenai Mountains-Turnagain Arm transportation corridor to promote public enjoyment of these resources, and receives and administers funds to support communities in developing projects that recognize, preserve, and interpret the Kenai Mountains-Turnagain Arm’s rich and scenic heritage; and

WHEREAS, the 2012 KMTA CCA Management Plan, approved by the Secretary of the Interior following nearly two years of public meetings, public comment, and community input, identified a bike touring route along the Hope Highway as a priority for the KMTA CCA board; and

WHEREAS, the 2003 Kenai Peninsula Borough Transportation Plan identified the Hope Highway as one of the highest priority locations for roadside trail improvement projects; and

WHEREAS, the community of Hope has designated a separated, non-motorized path within the community of Hope as its highest capital improvement project priority in 2016 and 2017; and

WHEREAS, the community of Hope is becoming increasingly popular with more visitors which results in considerably more traffic on the Hope Highway and through the community; and

WHEREAS, the Hope Highway is a two lane paved road with minimal shoulders, and there is a need for a dedicated non-motorized pathway along the highway; and

WHEREAS, the KMTA CCA is pursuing funding and partnerships for this project through multiple avenues including the Federal Lands Access Programs Grant and is requesting a resolution of support to assist their efforts, with no financial or staff time obligation from the borough; and


WHEREAS, the borough believes that the construction of a non-motorized bicycle pathway from the Seward Highway to Hope will be beneficial to borough residents;

NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

SECTION 1. That the Kenai Peninsula Borough supports the KMTA CCA efforts to pursue funding and partnerships to plan and develop a non-motorized trail along the Hope Highway.

SECTION 2. That this resolution takes effect immediately upon its adoption.

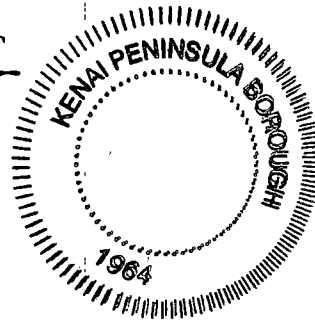
