On May 26, 2015 the Kenai Peninsula Borough Road Service Area formally solicited bids for Old Mill Subdivision Roads Flood Damage Repair Project for completion in summer 2015. The invitation to bid was advertised in the Peninsula Clarion May 26, 29 and June 1, 2015 and in the Seward Journal May 27 and June 3, 2015.

On the due date of June 10, 2015 three (3) bids were received and reviewed to ensure that all the specifications and delivery schedules were met. Attached is a copy of the bid tabulation sheet.

The lowest responsive bid was received from Metco, Inc. in the amount of \$449,777.50.


