SUBJECT: Authorization to Award Contract for ITB16-034, 2016 CIP Monica St, Kenai Dr, Cooper St & Poplar Ave Project No. C1MON

On April 21, 2016 the Kenai Peninsula Borough Road Service Area formally solicited bids for the Monica Street, Kenai Drive, Cooper Street & Poplar Avenue Capital Improvement Project No. C1MON with completion in September 2016. The invitation to bid was advertised in the Peninsula Clarion on April 21, 2016.

On the due date of May 12, 2016 seven (7) bids were received and reviewed to ensure that all the specifications and delivery schedules were met. Attached is a copy of the bid tabulation sheet.

The lowest responsive bid was received from Hammond Trucking & Excavating, Inc, PO Box 215, Soldotna, Ak 99669, in the amount of \$149,591.35. The total cost for this project is \$164,725.51, which includes design services, contract services, inter-department charges, and contingencies.

The Kenai Peninsula Borough Assembly approved through Fiscal Year 2016 Budget, the Monica Street, Kenai Drive, Cooper Street & Poplar Avenue No. C1MON Capital Improvement Project. This project has been approved through Road Service Area Resolution 2015-11, Approving Road Projects Included as Fiscal Year 2016 Capital Improvement Projects. Expenditures for the contract will be charged to account number 434.33950.C1MON.49999.
