Please vote no on Ordinance 2015-14 and retain 50 foot buffers on anadromous waters in our Borough. It's not just the Kasilof and Kenai watersheds that need protecting.

We live on Daniels Lake in Nikiski, and the back of our home, built decades ago, lies just within the 50 foot buffer. Because of our proximity to the lake, this older home is experiencing rotting from the moist conditions. When we set about to repair this, we contacted the River Center to see about a permit. We so enjoy the privilege and pleasure of watching the lake all year, that we wanted to make sure our activities would do no harm to the lake edge and its many inhabitants. Then we got worried! These repairs are necessary, but would it be a hassle? Would they let us? Would it cost a lot of time and money? Karyn Noyes is a Resource Planner with the Kenai Peninsula Borough River Center Department and has been very easy to work with. She understood our situation, was helpful and quick in getting us permitted and letting us know how best to proceed. It has all been very pleasant and positive.

We all love these places and these resources or we wouldn't live here. Please continue to protect the 50 feet along the water's edge on all anadromous streams and lakes. It helps us all.
