The Borough Canvass Board has canvassed the October 6, 2020 Regular Election ballots cast by the five By-Mail precincts; the absentee ballots cast by mail, fax and in person; special needs ballots and the questioned ballots cast at the polls on election day. Our findings are as follows:



We, the undersigned, certify the foregoing to be true and accurate to the best of our knowledge and belief.


