KENAI PENINSULA BOROUGH ORDINANCE 2014-19-55

AN ORDINANCE ACCEPTING AND APPROPRIATING FUNDS IN THE AMOUNT OF \$842,848.95 FROM THE STATE OF ALASKA DIVISION OF HOMELAND SECURITY & EMERGENCY MANAGEMENT, PUBLIC ASSISTANCE PROGRAM APPROVED THROUGH FEDERAL DECLARATION DR-4094

- WHEREAS, the borough responded to flood occurrences causing significant damage in many communities within the borough; and
- WHEREAS, a disaster was declared by the borough mayor and the State of Alaska Governor on September 21, 2012, and by President Obama on November 5, 2012; and
- WHEREAS, the Federal Declaration DR-4094 approved eligible expenses associated with response, recovery and mitigation to be reimbursed by the Federal Emergency Management Agency and the State of Alaska through the Public Assistance Program (FEMA PA); and
- WHEREAS, the borough approved and appropriated funds for fourteen (14) project worksheets through the FEMA PA program by way of Ordinance 2012-19-55; and
- WHEREAS, the approved FEMA PA Project Worksheet 55 funds have been increased from \$60,510.49 to \$903,359.44 for incurred and estimated costs to complete predisaster road work in the Old Mill and Old Exit Glacier Subdivisions; and
- WHEREAS, the eligible costs will be reimbursed to the borough as a 75 percent federal passthrough and a 25 percent state-matching grant awarded by the State of Alaska Division of Homeland Security & Emergency Management; and
- WHEREAS, at its regular meeting on April 14, 2015 the Road Service Area Board considered RSA Resolution 2015-03 and recommended acceptance of the grant funds;

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

SECTION 1. That the mayor is authorized to accept grant funds in the amount of \$842,848.95 from the State of Alaska Division of Homeland Security & Emergency Management for the 2012 Flood Disaster DR-4094 Project Worksheet 55(1).

- **SECTION 2.** That \$903,359.44 is appropriated to account no. 260.11251.13F55.49999.
- **SECTION 3.** That appropriations made in this ordinance are of a project length nature and as such do not lapse at the end of any particular fiscal year.
- SECTION 4. That the mayor is authorized to execute grant agreements and any other documents deemed necessary to accept and expend the funds, and to fulfill the intents and purposes of this ordinance.

SECTION 5. That this ordinance shall be effective upon its enactment.
