**KENAI PENINSULA BOROUGH
ORDINANCE 2015-19-01**

AN ORDINANCE ACCEPTING AND APPROPRIATING GRANT FUNDS TOTALING \$28,071.10 FROM THE ALASKA DEPARTMENT OF NATURAL RESOURCES FOR THE VOLUNTEER FIRE ASSISTANCE PROGRAM ON BEHALF OF ANCHOR POINT FIRE AND EMERGENCY MEDICAL SERVICE AREA, KACHEMAK EMERGENCY SERVICE AREA, AND NIKISKI FIRE SERVICE AREA

WHEREAS, Anchor Point Fire and Emergency Medical Service Area (APFEMSA), Kachemak Emergency Service Area (KESA), and Nikiski Fire Service Area (NFSA) each applied for a grant under the 2015 Volunteer Fire Assistance Program administered by the State of Alaska Department of Natural Resources, Division of Forestry; and

WHEREAS, the borough received award notification, allowing the service areas to purchase wildland firefighting equipment; and

WHEREAS, the Volunteer Fire Assistance Program requires a 10 percent match of local expenditures toward the grant funds; and

WHEREAS, the service areas will meet the match requirement through expenditures made from their FY16 operating budget prior to December 31, 2015; and

WHEREAS, at a special meeting on February 25, 2015, the APFEMSA board recommended unanimous approval to accept the grant funds in the amount of \$10,000 and to meet the 10 percent match requirement; and

WHEREAS, at its regular meeting on February 26, 2015, the KESA board recommended unanimous approval to accept the grant funds in the amount of \$8,766 and to meet the 10 percent match requirement; and

WHEREAS, at its regular meeting on March 11, 2015, the NFSA board recommended unanimous approval to accept the grant funds in the amount of \$9,305.10 and to meet the 10 percent match requirement;

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

SECTION 1. That the mayor is authorized to accept the Volunteer Fire Assistance Program grant funds from the Alaska Department of Natural Resources on behalf of Anchor Point Fire & Emergency Medical Service Area, Kachemak Emergency Service Area, and Nikiski Fire Service Area and is authorized to execute the grant agreements and any other documents deemed necessary to accept and expend the grants and to fulfill the intents and purposes of this ordinance.


SECTION 2. That APFEMSA grant funds in the amount of \$10,000 are appropriated to the following account: 209.51410.16VF2.49999.

SECTION 3. That KESA grant funds in the amount of \$8,766 are appropriated to the following account: 212.51810.16VF3.49999.

SECTION 4. That NFSA grant funds in the amount of \$9,305.10 are appropriated to the following account: 206.51110.16VF1.49999.

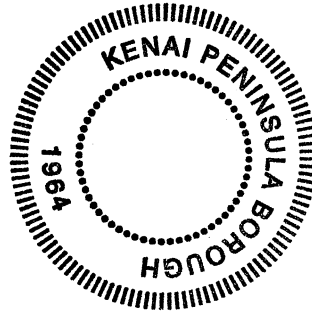
SECTION 5. This ordinance shall become effective immediately upon its enactment.
