- SECTION 5.** That in Assembly District 8, Kelly Cooper was elected to a 3-year term, having received the greatest number of votes cast.
- SECTION 6.** That in the Board of Education District 3, Jason A. Tauriainen was elected to a 3-year term, having received the greatest number of votes cast.
- SECTION 7.** That in the Board of Education District 4, Penny Vadla was elected to a 3-year term, having received the greatest number of votes cast.
- SECTION 8.** That in the Board of Education District 5, Kelly Cizek was elected to a 1-year term having received the greatest number of votes cast.
- SECTION 9.** That in the Board of Education District 7, Dianne Macrae was elected to a 3-year term, having received the greatest number of votes cast.
- SECTION 10.** That in the Bear Creek Fire Service Area, Jena Petersen was elected to Seat E for a 3-year term, having received the greatest number of votes cast.
- SECTION 11.** That in the Joint Operations Board for Central Peninsula Emergency Medical Service Area, Gary Hale was elected to Seat E for a 3-year term, having received the greatest number of votes case.
- SECTION 12.** That in the Nikiski Fire Service Area Board Area, the following were elected having received the greatest number of votes cast:

SECTION 16. That in the South Kenai Peninsula Hospital Service Area, the following were elected having received the greatest number of votes cast:

- Seat D – Roberta Highland for a 3-year term
- Seat E – Francie Roberts for a 3-year term
- Seat F – Tamara Fletcher for a 3-year term
