WHEREAS, Pursuant to, and as authorized by KPB 16.41.080, the Rules and Regulations for Operation of the Kenai Peninsula Borough Road Service Area, Article I, Contracts, the Road Service Area Board recommends to the Mayor the award of a contract to the lowest responsive, responsible, qualified bidder in accord with KPB 5.28.200; and
