**KENAI PENINSULA BOROUGH  
ORDINANCE 2016-19-08**

**AN ORDINANCE ACCEPTING AND APPROPRIATING \$491,930.94 FROM THE STATE OF ALASKA DEPARTMENT OF MILITARY AND VETERANS AFFAIRS, DIVISION OF HOMELAND SECURITY AND EMERGENCY MANAGEMENT TO PURCHASE RADIO CONSOLES AND TO CONDUCT TRAINING**

**WHEREAS**, the State of Alaska Department of Military and Veterans Affairs, Division of Homeland Security & Emergency Management (DHS&EM) provides funds to enhance the capability of local governments to prevent, deter, respond to and recover from all-hazard incidents and to enhance regional preparedness efforts; and

**WHEREAS**, the DHS&EM State Homeland Security Program (SHSP) is a federal grant pass through program with the Federal Emergency Management Agency which provides funding for planning, equipment, training and exercises; and

**WHEREAS**, DHS&EM has approved SHSP funding in the amount of \$7,275 to conduct Community Emergency Response Team training and \$484,655.94 to purchase radio consoles for the Soldotna Public Safety Communication Center; and

**WHEREAS**, it is in the best interest of the borough to accept the grant funds;

**NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:**


**SECTION 1.** That the mayor is authorized to accept \$491,930.94 from the State of Alaska Department of Military and Veteran Affairs, Division of Homeland Security and Emergency Management and to execute a grant agreement and any other documents deemed necessary to accept and to expend the grant funds and to fulfill the intents and purposes of this ordinance.

**SECTION 2.** That grant funds in the amount of \$7,275 are appropriated to account 271.11250.17HSP.49999.


**SECTION 3.** That grant funds in the amount of \$484,655.94 are appropriated to account 271.11255.17HSP.49999.


**SECTION 4.** This ordinance shall become effective immediately upon its enactment.
