SUBJECT: Authorization to Award Contract for North Peninsula Recreation Center Gym Floor Installation

The Purchasing and Contracting Office formally solicited and received bids for the North Peninsula Recreation Center Gym Floor Installation. Bid packets were released on February 25, 2016 and the Invitation to Bid was advertised in the Alaska Dispatch News and the Peninsula Clarion on February 25, 2016.

The project consists of installing a new Gym Floor "TURNKEY" at the North Peninsula Recreation Center (all materials, freight, labor, room, board, travel) including: Provide and Install approximately 5796 sf of Robbins Sportwood over Bio channel gym floor, new vented cove base; cut existing floor into approximately 4' x 8' panels and stack outside the nearest exit; remove and reinstall bleachers; reinstalling two (2) existing Volleyball sleeves, providing new cover plates for the existing sleeves and installing four (4) additional sleeves with cover plates.

On the due date of March 15, 2016 One (1) bid was received and reviewed to ensure that all the specifications and delivery schedules were met. The low bid of \$132,400.00 was submitted by Alaskan Industries, Inc., Wasilla, Alaska.


