SUBJECT: Authorization to Award Contract for ITB17-020 Carver Drive, Frogberry Street and Knoll Court Project No.C5CAR

The Purchasing and Contracting Office formally solicited bids for project ITB17-020 Carver Drive, Frogberry Street and Knoll Court Project No.C5CAR. Bid packets were released on February 21, 2017 and the invitation to bid was advertised in the Peninsula Clarion on February 21, 2017.

The project consists of furnishing all labor, materials, and equipment to upgrade these roads. Work includes but is not limited to roadbed widening, subgrade modification, embankment construction, drainage, ditching and clearing.

On the due date of March 23, 2017, eight (8) bids were received and reviewed to ensure that all the specifications and delivery schedules were met. The low bid of \$336,366.27 was submitted by Big Mike's General Contracting. The total cost for this project is \$433,095.00 which includes design services, contract services, inter-department charges, and contingencies.

This project has been approved through the Road Service Area Board at their January 24, 2017 meeting approving road projects be included as FY17 capital improvement projects.
