Dear Mayor & Borough Assembly Members;

I am hoping you will read my letter in public at the March 17th Borough Assembly Meeting. I don't think I am going to be able to make it to the meeting on that date, but I appreciate the opportunity to voice my opinion via a letter.

First of all, I want to extend my respect to everyone who feels passionately about this issue. Thank you for reading my thoughts.

I support Blaine Gilman's ordinance. The state of Alaska has just revised the state income tax system, ending the ACES system & implementing the MAPA system. This means that the state is not generating as much income as it has in previous years. My understanding is that the state of AK is actually hemorrhaging money, in comparison to years past, so I believe we have to think fast & creatively about how to make up for budget deficits.

I live in Nebraska for 7 years in the 1990's. Everyone there contributed to a state income tax. No one liked it & they all complained about it, & the state of Nebraska was solidly red. However, being the good Mid-Westerners that they were, they always operated in the black. In general, the elected officials tried to figure out ways to save money before stripping away the state's income base.

The state of Alaska has positioned herself in a vulnerable spot, since the vast majority of her tax revenues are based on the oil industry. We need some fantastic leaders who will help us envision a future of economic diversification so that we will be able to generate our revenue from a variety of sources. This will take some ultra-brave leadership & a fair amount of tenacity.

For the time being, since the state's budget has been cut so drastically in such a short time, I encourage you to vote "Yes" in favor of the ordinance. However, you may look at implementing the winter grocery tax for 2-3 years & then re-visit the issue. This would give you the temporary revenue you need to fund your schools while you think of another way to fund the schools.

In the meantime, you may consider following Governor Walker's lead, which was to send out a comment form to Alaskans, asking them how to save tax revenues. This might bring out some ideas about better & more diverse ways of generating revenue. People, in general, are quite creative & ingenious in their ideas & that type of wealth should be spread around for everyone's benefit.

A final word about our local schools . . . I have 2 boys – ages 7 & 10 who attend KPBSD Schools. I've been extremely pleased with their quality of education & the teachers. It's really important to stand behind our teachers, as some of our students come from some pretty difficult homes. Also, it's important to support our families who are trying to make ends-meet & keep their families functional. Maybe we could simply reframe the conversation in more respectful & supportive language. I say that to everyone out there listening to this letter – be kind with your words! We need to let the folks who work with our children know that we've got their backs, & can work as a community to get through difficult times, no matter what the budget or what happens. We need to let them know that we're willing to think creatively in order to fulfill our obligation to our children's education. Most of us have kids, nieces, nephews, grandkids, or friends with kids, and we really, truly, & honestly do care!

Thank you for reading through my letter. I appreciate your time devoted to serving our community on the Borough Assembly.

Dear Assembly Members,

I understand that you want to assist the education group by looking for ways to fund them. However, even the School Board voted NOT to support taxing winter groceries as an option, with a 6-3 vote AGAINST supporting Gilman's Ordinance 2015-03. The School Board does not know where they will get funding, but they do understand that the voters have spoken multiple times and they do not want to disenfranchise thousands of local voters. I respect and appreciate their decision.

As for the 2015-03 Ordinance Substitute (changing the 9 month winter grocery tax exemption to 6 months, thereby extending the summer grocery tax from 3 months to 6 months), that is STILL disenfranchising the will of the voters and going against how they voted. If you approve this, or Ordinance 2015-03, that would be giving credibility to winter grocery taxation and the overwhelming majority of voters are strongly opposed to that. It is likely that the voters will vote it down if you do happen to send either Ordinance 2015-03 or Ordinance 2015-03 Substitute to the ballot this October. An elected representative, in my opinion, should listen to his or her constituents and respect the will of the people. I know how the voters have spoken out and voted against winter grocery taxation, by looking at the 2008 and 2011 election results. If brought to the voters yet again on the October ballot, I do believe this will further infuriate the voters. I have heard so many voters say "Why do they keep bringing this back up?", "Why do we have to keep voting on it?", and "What part of NO do they not understand?"

Many local people already see the assembly as not truly representing them and I think this will further antagonize the voters. Those are my thoughts and observations based on listening to the voters and getting feedback from them, both recently in the past couple of weeks, and back in the fall of 2014 when I witnessed about 1,000 petition signatures for our citizens' referendum, now Proposition One on the ballot this October. Our citizens' proposition would uphold the other part of the voter approved 2008 grocery tax exemption initiative by not allowing the borough to give authorization to the general law cities to tax winter groceries.

What I hope the assembly understands, is that while the borough is looking for funding, the people in our community, both in the cities and rural areas, are hurting and struggling economically. Food is a highly regressive tax, hurting the most those who cannot afford it. More friends and neighbors, including the elderly, are showing up at our local food pantries for help with food, their basic necessity. Mr. Gilman has expressed his opinion that the concept of this being a "regressive tax" is our "best argument." While that is not our only argument, not listening to the voters is also a huge one, a regressive tax in our community should matter very much to our elected officials. Just because someone considers the additional tax to be simply the price of a "latte" per week, it actually does greatly affect families with children, the elderly and folks on fixed incomes. This group of people make up a significant percentage of our community.

If you look at the Official USDA Alaska and Hawaii Thrifty Food Plans: Cost of Food at Home (2nd half 2014) chart, at <u>http://www.cnpp.usda.gov/USDAFoodPlansCostofFood/reports</u>, the monthly cost of food for a family of four is \$767.60. So for example, when a family shops at Fred Meyers in Soldotna, under the full taxation rate that both of these ordinances are proposing, a 6% tax on groceries (the borough's 3% and the City of Soldotna's 3% tax), is \$46 per month. That would be almost TWO DAYS worth of food in one month for a family of four. That is not healthy for the people in our community.

I strongly urge ALL of you to vote AGAINST Ordinance 2015-03 and Ordinance 2015-03 Substitute. Anything other than a NO vote would NOT be listening to the will of the people and how they have already voted multiple times and how they still currently feel about this issue.

Sure, you can bring it to a vote of the people YET AGAIN. However, the majority of people are already very fed up with the assembly recycling the winter grocery tax issue over and over again. It would be nice to have an assembly that supports the will of the people and listens to what they are saying. The assembly could do this by ENDING both proposed grocery tax ordinances with NO votes on both of them this Tuesday, March 17th at the 6pm borough assembly meeting.

The funding for the KPBSD is a very important and substantial portion of the KPB collected tax revenue.

I am firmly in support of education of the children of the KPB, but also aware that care must be taken to assure that funds are directed toward the children versus administrative wants. Below are a number of questions that I believe should be asked and answered prior to making a funding amount decision. They are not in any particular order.

The most important consideration should be **Students and Classroom Teachers**. Protect teaches wages/ benefits and student necessities/ activities.

What is the administrative ratio of staff to CLASSROOM teachers. Terms such as "certified" should not be classified as classroom if they are not in the classroom itself. Compare that to real world staff versus line ratios.

The previous superintendent mentioned federal grant programs for non-teaching positions that the KPBSD has deployed, with expired grants, and that the KPBSD wants to continue. At what cost? If they are not direct student related, they should not be a budgetary consideration. Administrative "feel good" should not be considered versus Student Essential.

How many "non-student essential" grant programs is the KPBSD asking to be funded?

Why should the KPB consider funding non-student essential programs.

What is the plan to reduce student transportation costs? Many buss's are on routes with very few students on board? Is the KPBSD planning to contract for less expensive and smaller van type buss's for those routes?

Why does the KPBSD have a finance/ purchasing division just a short walk from an excellent KPB finance department? Is the KPBSD amenable to combining the two and saving considerable funds?

There are many more questions that you are probably considering and perhaps a few of these can be added to your list.
