## KENAI PENINSULA BOROUGH RESOLUTION 2025-022

A RESOLUTION AUTHORIZING A LEASE AGREEMENT WITH SKYLINE TOWERS, LLC FOR THE CONTINUED USE OF THE KACHEMAK EMERGENCY SERVICE AREA EMERGENCY COMMUNICATIONS SITE

- WHEREAS, in 2002 the Kenai Peninsula Borough (KPB) Office of Emergency Management (OEM) entered into an annual rental agreement for an emergency communications site located at 61115 Skyline Drive near Homer; and
- WHEREAS, rental agreement renewals were executed in subsequent years, with the Kachemak Emergency Service Area (KESA) assuming monthly rental payments since 2007; and
- WHEREAS, the current rental agreement will expire on June 30, 2025; and
- WHEREAS, KESA desires to continue its use of the emergency communications site; and
- WHEREAS, securing a long-term lease agreement will ensure the continued availability of the site for KESA emergency communications; and
- WHEREAS, the Lessor has agreed to a five-year lease agreement with renewal options at a monthly rate of \$260 (\$3,120/annually) to cover space rental and utility costs; and
- **WHEREAS**, no relocation costs will be incurred by KESA with the continued use of the existing site; and
- **WHEREAS,** the KESA Board at its April 17, 2025, meeting recommended approval of the lease agreement; and
- **WHEREAS,** the KPB Planning Commission conducted a public hearing during its regularly-scheduled meeting on May 12, 2025, and recommended approval by unanimous consent;

NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

**SECTION 1.** That KPB is authorized to secure a five-year lease with renewal options from Skyline Towers, LLC, of tower and equipment storage space (the Lease) on that property more particularly described as follows:

E½W½W½NE¼NE¾ lying south of Skyline Drive, Section 2, T06S, R13W, Seward Meridian, Homer Recording District, Third Judicial District, State of Alaska. The physical address of the property is 61115 Skyline Drive' Homer, AK 99603 (KPB parcel number 17406108).

Site Name: Skyline Towers Communications Site

- **SECTION 2.** That the purpose of the Lease is for the continued use of KESA's emergency communications site.
- SECTION 3. That the monthly rental will be \$260.00 for the initial five-year term of the Lease. On each anniversary of the effective date, rent will adjust annually by not more than three percent (3%) over the prior year's rent amount to account for any increases in the electric cost portion of the rent documented by Skyline Towers, LLC.
- **SECTION 4.** That pursuant to KPB 17.10.080(C), no land classification is proposed for this leased property.
- **SECTION 5**. That expenditures for the Lease will be charged to account number 212-51810-00000-43810.
- **SECTION 6.** That the Mayor is authorized to execute an agreement substantially in the form of the Lease Agreement submitted with this resolution and to make all agreements deemed necessary in accordance with this resolution.
- **SECTION 7.** That this resolution is effective immediately.
