WE ARE A NON-PROFIT ORGANIZATION ESTABLISHED TO PRESERVE, MAINTAIN AND ENHANCE MOOSE HABITAT ON THE SOUTHERN KENAI PENINSULA. WE INCORPORATED IN 1996 AS A RESULT OF FERC (FEDERAL ENERGY REGULATORY COMMISSION) REQUIREMENTS REGARDING LOST HABITAT DUE TO THE BRADLEY LAKE HYDROELECTRIC PROJECT.

KMHI HAS PRESERVED APPROXIMATELY 771 AC ON SOUTHERN KENAI PENINSULA.
