## KENAI PENINSULA BOROUGH ORDINANCE 2014-19-37

## AN ORDINANCE ACCEPTING AND APPROPRIATING \$24,427.25 FROM THE U.S. DEPARTMENT OF INTERIOR, FISH AND WILDLIFE SERVICE FOR THE PLANNING AND ADMINISTRATION PROJECT UNDER THE COASTAL IMPACT ASSISTANCE PROGRAM

- WHEREAS, the Coastal Impact Assistance Program (CIAP) was established under Section 384 of the Energy Act of 2005 and authorizes the Secretary of the Interior to disburse funds to Outer Continental Shelf oil and gas producing states; and
- WHEREAS, the purpose of the CIAP is to provide funding through a non-competitive grant process to oil and gas producing states to mitigate the effects of offshore oil and gas activities; and
- WHEREAS, the Planning and Administration project (P&A) is one of the projects approved by the Kenai Peninsula Borough Assembly through adoption of KPB Resolution 2007-032 and Resolution 2009-018; and
- WHEREAS, the P&A funds were approved and appropriated by way of Ordinances 2008-19-50, 2009-19-12, and 2010-19-29 for a total amount of \$154,383.06 to complete project management tasks directly associated with CIAP projects; and
- WHEREAS, the P&A grant ended December 31, 2013 with a remaining balance of \$61,170.31; and
- WHEREAS, the borough applied for and received notification from Fish and Wildlife Service to allocate a reduced budget of \$24,427.25 to complete the remaining P&A tasks; and
- **WHEREAS**, this ordinance will approve and appropriate the revised P&A grant under a new award in the amount of \$24,427.25;
- NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:



- **SECTION 1.** That the mayor is authorized to accept the remaining funds from the U.S. Department of Interior, Fish and Wildlife Service in the amount of \$24,427.25 through its Coastal Impact Assistance Program, and is authorized to execute grant agreements and any other documents deemed necessary to accept and expend the grant and fulfill the intents and purposes of this ordinance.
- **SECTION 2.** That grant funds totaling \$24,427.25 are hereby appropriated to account number 271.21135.15791.49999, CIAP Planning and Administration, for the purpose of completing project management tasks.
- **SECTION 3.** That due to the length and nature of this project, the appropriation established through the ordinance shall not lapse at the end of any particular fiscal year.
- **SECTION 4.** This ordinance shall become effective immediately upon enactment.
