**KENAI PENINSULA BOROUGH
RESOLUTION 2017-049**

**A RESOLUTION TRANSFERRING FUNDS FROM A COMPLETED PREVIOUSLY
APPROPRIATED CAPITAL PROJECT TO BE USED TO ADDRESS CHANGES TO
THE STRUCTURAL SCOPE IN CENTRAL PENINSULA HOSPITAL RADIOLOGY
PHASES III, IV AND V RENOVATION PROJECTS**

WHEREAS, the Kenai Peninsula Borough Purchasing and Contracting Department has identified the need for additional funds to address changes to the structural scope in Central Peninsula Hospital (“CPH”) Radiology Phases III, IV and V renovation projects; and

WHEREAS, they are requesting that remaining funds of \$61,756.96 from the completed CPH Radiology 2A project be redirected for this purpose; and

WHEREAS, KPB 5.04.100 authorizes the assembly to transfer unencumbered balances by resolution at the budgetary control level; and

WHEREAS, the budgetary control level for capital project funds is at the project level and this transfer is at the project level; and

WHEREAS, during the CPH Radiology Phases III, IV and V renovation projects it was discovered that several areas of older construction did not match the structural records drawings, ongoing operational requirements limited the ability to review the existing conditions prior to the design work, and as part of the phased construction it was discovered that multiple code and operational needs will be directly impacted by the existing structure as it is built; and

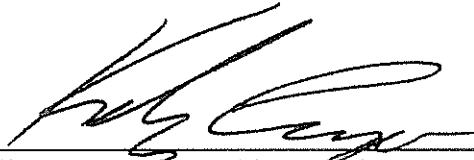
WHEREAS, changes to the structural scope are required to accommodate these needs, and based on the current estimates, \$61,756.96 should be sufficient to complete the required additional work;

**NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI
PENINSULA BOROUGH:**

SECTION 1. That funds in the amount of \$61,756.96 previously appropriated for project number 490.81110.13IMG.49999 CPH Radiology 2A project are transferred to CPH Radiology Phases III, IV and V renovation projects, project number 490.81110.15IMG.49999.

SECTION 2. This resolution shall become effective immediately upon its adoption.

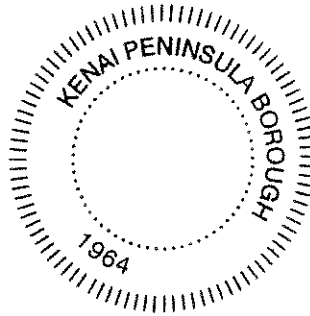
