The text for my testimony last night was taken almost verbatim from Page 58 of the Strategic Action Plan for the Mat-Su Basin Salmon Habitat Partnership discussing Riparian Integrity. The Plan is available using the link below (I apologize, but my e-mail server does not allow me to include direct hyperlinks). I wrote that section of the plan back in 2007 during the initial development of the Partnership's Strategic Action Plan, and the original text includes references to peer-reviewed scientific literature. I am acknowledged on Page 1 as co-editor of the 2008 plan.

To all borough assembly members and borough mayor,

Please vote against the changes to the riparian changes ordinance 2015-14.

It's clearly understood in the scientific community that intact riparian habitat around our lakes and streams is important to sustain and propagate wild salmon. Habitat buffers along our lakes and streams prevent inordinate erosion at critical times when salmon are spawning and rearing, and they help retain vegetative cover which provides important habitat throughout the salmonid lifecycle. Furthermore, these setbacks help protect property values by stabilizing lake and stream banks, and reducing the impacts caused by flooding.

Ordinance 2015-14 actually recognizes the benefits of salmon habitat buffers because it retains them in the Kenai and Kasilof watersheds. It makes little sense, however, to protect just two watersheds in the Kenai Borough, while leaving hundreds of other lakes and streams unprotected.

The 50 foot habitat buffer currently in-place is a reasonable compromise; there's ample evidence that larger setbacks are warranted in many systems that support wild salmon. Please retain the sensible safeguards currently in place.
